5. <u>New Business</u>

a) Approval of Resolution to Include Compensation Paid Under an Internal Revenue Code Section 125 as IMRF Earnings (Pre-Tax Payroll Deductions for Group Health Spouse and Dependent Coverage): Cary Minnis explained that this resolution will ensure that any payroll deductions for dependent health coverage will be included as earnings for IMRF contributions.
