## 4. New Business

#### a) Local Share for FY25

Cary referred to the Local Share list in today's packet. The amounts have not changed since last year and are based on population. The last count was done in 2020.

A motion was made by Mark Krones and seconded by Gary Williams to approve the FY Local Share amounts as listed and discussed. The motion carried by unanimous vote.

# b) FY 2025 Greater Egypt Budget

Cary went over the budget for FY 2025. He noted the following:

- We will need to add one more Environmental Planner as soon as possible.
- \$10,000 is budgeted for legal expenses. We plan to have our policy manual and job classifications reviewed and updated as needed.
- We will be using funds from LGS (only unrestricted funds besides Enterprise Zone fees) to cover a Windows 11 upgrade for all staff. This has been recommended by Alan Doty and will cost around \$10,000. We will also be spending around \$1,500 on Greater Egypt shirts for the staff.

## c) Safe Streets and Roads for All Planning

Cary announced that IDOT is putting plans together for the MPO area along the Route 13 corridor, the rural portions of Jackson County, and for the counties of Perry, Franklin, and Jefferson. They would like Greater Egypt to help coordinate and Cary is asking for safety committee volunteers. Please reach out if interested.

## d) SIMPO

Cary explained that the MPO was formally decommissioned on June 30, 2024 and this was acknowledged by the MPO at the June 10, 2024 meeting. Our current contract for FY24 does not expire until December 31, 2024, this will allow us to spend out the grant and finish up consultant studies that are ongoing. This is a huge hit for us and the regions that the MPO served as we were receiving around \$300K per year. We have completed 34 studies during the past 10 years, bringing more than \$70 million to the region. We are replacing the lost income with SPR grants (Bike Plans, Safety Studies, etc.). We currently have two of these in progress, bike plans for the Tri-C area and for Pinckneyville/Du Quoin.
